



**INDIGENOUS ENABLING  
COMMONWEALTH EDUCATION COSTS SCHOLARSHIP (IECECS)  
2015 TERMS AND CONDITIONS**

**WHAT THIS SCHOLARSHIP PROVIDES**

The Indigenous Enabling – Commonwealth Education Costs Scholarship (IECECS) for 2015 will provide the following:

- \$1,271.50\* cash payment per semester to assist with costs associated with studying (textbooks, incidental expenses etc.) for up to 2 semesters maximum or at the completion of your course, whichever is earlier.

If you have already received the Indigenous Enabling – Commonwealth Education Costs Scholarship from any providers, your maximum entitlement will be reduced.

You **cannot** receive the IECECS and the Student Start-up Scholarship from Centrelink at the same period.

If you receive a Centrelink payment, you should declare to Centrelink any scholarships you are awarded.

**CONDITIONS THAT NEED TO BE MET TO KEEP YOUR SCHOLARSHIP**

- 1) Deferral of this scholarship is not permitted  
Unless there are **exceptional circumstances**:
  - Remain eligible for a Commonwealth Supported place at Curtin University.
  - Maintain a full-time enrolment of at least 75 credit points per semester at Curtin University. If any study is undertaken below 75 credits per semester, you are required to seek approval for this change from the Scholarships Office.
  - Maintain a course weighted average (CWA) of at least 50 and fail no more than one unit per semester Academic monitoring of scholarship recipients will occur each semester.
- 2) You must not be in receipt of a Student Start-up Scholarship from Centrelink or the Department of Veterans' Affairs.
- 3) You must advise the Scholarships Office immediately if your financial situation changes from what was provided in your initial scholarship application.
- 4) If you cease studies at Curtin, either voluntarily (e.g. by withdrawing from course or units) or involuntarily (e.g. termination from course due to unsatisfactory course progress or suspension, termination or expulsion due to misconduct), you will become ineligible for continuation of this scholarship. The scholarship will cease immediately and you will be required to repay any stipend awarded for the most recent study period.
- 5) Scholarship leave of absence may be permitted for up to a maximum of 12 months over the duration of the scholarship. You must apply in writing and approval is at the discretion of the Scholarships Office.
- 6) If you intend to change your course of study you must first apply in writing and seek approval from the Scholarships Office in addition to getting approval from your faculty.
- 7) The IECECS is not transferable between universities.

Unless there are **exceptional circumstances**, if you have unsatisfactory progress or breach the scholarship conditions, you shall be ineligible to retain the scholarship. If you do not meet all the conditions outlined, you may be placed on a breached status which would provide an opportunity for you to improve your grades in the subsequent semester. This opportunity would occur only once for the duration of the scholarship.

**Exceptional circumstances** must be forwarded in writing to the Scholarships Office, along with any supporting documentation. The Scholarships Office will then assess your request and advise you of the outcome.

**PAYMENTS**

The IECECS will commence from semester 1, 2015.

The semester 1 cash payment of \$1,271.50 will be paid to your nominated bank account post census date (mid-late April). If applicable, the payment for semester 2 will be paid post census date (thus approx. mid-end Sept).

Cash payments are based on full-time enrolment of at least 75 credit points each semester.
