

**INDIGENOUS – COMMONWEALTH EDUCATION COSTS SCHOLARSHIP (ICECS)  
2016 TERMS AND CONDITIONS**

**WHAT THIS SCHOLARSHIP PROVIDES**

The Indigenous – Commonwealth Education Costs Scholarship (ICECS) for 2016 will provide the following:

- \$1,299.50\* cash payment each semester to assist with costs associated with studying (textbooks, incidental expenses etc.) for up to 8 semesters maximum or at the completion of your course, whichever is earlier.

*\*The value of the scholarship will be indexed annually.*

If you have already received the Indigenous – Commonwealth Education Costs Scholarship from any providers, your maximum entitlement will be reduced.

You **cannot** receive the ICECS and the Student Start-up Scholarship/Loan from Centrelink at the same period.

If you receive a Centrelink payment, you should declare to Centrelink any scholarships you are awarded.

**CONDITIONS THAT NEED TO BE MET TO KEEP YOUR SCHOLARSHIP**

- 1) Deferral of this scholarship is not permitted.
- 2) Unless there are **exceptional circumstances**:
  - Remain enrolled as an Internal Curtin University student.
  - Maintain a full-time enrolment of at least 75 credit points per semester at Curtin University. If any study is undertaken below 75 credits per semester, you are required to seek approval for this change from the Scholarships Office.
  - Maintain a course weighted average (CWA) of at least 50 and fail no more than one unit per semester. Academic monitoring of scholarship recipients will occur each semester.
- 3) You must not be in receipt of a Student Start-up Scholarship/Loan from Centrelink or the Department of Veterans' Affairs.
- 4) You must advise the Scholarships Office immediately if your financial situation changes from what was provided in your initial scholarship application.
- 5) If you cease studies at Curtin, either voluntarily (e.g. by withdrawing from course or units) or involuntarily (e.g. termination from course due to unsatisfactory course progress or suspension, termination or expulsion due to misconduct), you will become ineligible for continuation of this scholarship. The scholarship will cease immediately and you will be required to repay any stipend awarded for the most recent study period.
- 6) Scholarship leave of absence may be permitted for up to a maximum of 12 months over the duration of the scholarship. You must apply in writing and approval is at the discretion of the Scholarships Office.
- 7) If you intend to change your course of study you must first apply in writing and seek approval from the Manager, Scholarships Office in addition to getting approval from your faculty.
- 8) The ICECS is not transferable between universities

Unless there are **exceptional circumstances**, if you have unsatisfactory progress or breach the scholarship conditions, you shall be ineligible to retain the scholarship. If you do not meet all the conditions outlined, you may be placed on a breached status which would provide an opportunity for you to improve your grades in the subsequent semester. This opportunity would occur only once for the duration of the scholarship.

**Exceptional circumstances** must be forwarded in writing to the Scholarships Office, along with any supporting documentation. The Scholarships Office will then assess your request and advise you of the outcome.

**PAYMENTS**

The ICECS will commence from semester 1, 2016.

Cash payments of \$1,299.50\* will be paid to your nominated bank account each semester.

*\*The value of the scholarship will be indexed annually.*

Cash payments are based on full-time enrolment of at least 75 credit points per semester.

First and second semester payments will occur post census dates (thus approx. mid-end April and mid-end Sept).

**Note:** Your scholarship payment will appear on your bank statement with the reference as follows: DEPOSIT CONCUR TECHNOLOG CP#####.
