



**CGSB MBA SCHOLARSHIP  
2015 TRIMESTER 2 TERMS AND CONDITIONS**

**WHAT THIS SCHOLARSHIP PROVIDES**

The CGSB MBA Scholarship for 2015 will provide the following support as a one off payment:

- 1) Cash payment of \$5,000\*. The amount can be used at your discretion to contribute towards their fees, or for other education-related expenses and/or living expenses.

(\* ) The value of the scholarship is \$5,000 either full-time or part-time enrolment.

If you receive a Centrelink payment, you should declare to Centrelink any scholarship you are awarded.

The Australian Tax Office has a "[Is your Scholarship taxable?](#)" tool on their website to help you determine if your scholarship is taxable. For expert advice please contact the Australian Taxation Office or your accountant.

**CONDITIONS THAT NEED TO BE MET TO KEEP YOUR SCHOLARSHIP**

- 1) Be an Australian Citizen, Australian Permanent Resident or Australian Permanent Humanitarian Visa holder.
- 2) Be a commencing student in Trimester 2, 2015.
- 3) Be enrolled either full-time or part-time in the MBA program at Curtin University.
- 4) Successfully complete the first trimester in the MBA program.
- 5) If you cease studies at Curtin, either voluntarily (e.g. by withdrawing from course or units) or involuntarily (e.g. termination from course due to unsatisfactory course progress or suspension, termination or expulsion due to misconduct) in the semester of award, you will become ineligible to receive this scholarship. The CGSB MBA Scholarship will cease immediately and you will be required to repay any stipend awarded.
- 6) The CGSB MBA Scholarship is not transferable to another course, major or university.

**PAYMENTS**

The cash payment of the CGSB MBA will be paid to your nominated bank account in one instalment of \$5,000 after the end of Trimester 2, 2015 and will occur approximately early September.

Note: Your scholarship payment will appear on your bank statement with the reference as follows: DEPOSIT CONCUR TECHNOLOG CP#####.
