

JOHN CURTIN UNDERGRADUATE SCHOLARSHIP 2015 TERMS AND CONDITIONS

WHAT THIS SCHOLARSHIP PROVIDES

The John Curtin Undergraduate Scholarship (JCUS) for 2015 will provide one of the following options:

Once an option has been selected it **cannot** be changed for subsequent years.

Any study that is taken over and above the expected duration of your initial degree will not be covered.

OPTION 1

- 1) The cost of your student contribution fees* each year for the expected duration of the degree** for which the scholarship was offered.
- \$1,000 cash payment per semester. The stipend can be used at your discretion to contribute towards educational related expenses.
- 3) A one off payment of \$6,000 towards an approved international experience.
- 4) Allocated current JCUS Scholar mentor throughout degree.
 - * Excludes Student Services Amenities Fee
 - ** The expected duration of the scholarship is based on recipients undertaking a full-time study load of 200 credits per year. Any study that is taken over and above the expected duration of your initial degree will not be covered.

OPTION 2

- \$4,000 cash payment per semester to assist with educational related expenses for the expected duration of the degree** for which the scholarship was offered.
- 2) A one off payment of \$6,000 towards an approved international experience.
- 3) Allocated current JCUS Scholar mentor throughout degree.

If you receive a Centrelink payment, you should declare to Centrelink any scholarships you are awarded.

The Australian Tax Office has a <u>"Is your scholarship taxable?"</u> tool on their website to help you determine if your scholarship is taxable. For expert advice please contact the Australian Taxation Office (<u>www.ato.gov.au</u>) or your accountant.

JCUS recipients are also eligible to apply for the John Curtin Leadership Academy (JCLA). The JCLA is Curtin University's most prestigious leadership program. This is a unique opportunity for scholars to participate in a program that uses a variety of mediums to develop students, including residential workshops, interactive learning modules, personal mentoring and a group community project.

INTERNATIONAL EXPERIENCE

You are required to undertake an approved international experience as a JCUS Scholar.

You should contact your JCUS Co-ordinator in your first year to commence planning for your international experience. The international experience should take place by the penultimate semester at the latest. Significant planning is often required to arrange a program in a desired location which fits within Curtin University degree requirements.

You can ONLY utilise the amount reserved for an international experience if all of the following conditions are met:

- Your international experience has the approval of your Head of Department/School/Faculty Co-ordinator and your JCUS co-ordinator
- Your experience either:
 - A. Involves enrolling in an International Study unit (Study Exchange) or career development such as an internship or placement* (which can take place at the end of your course if necessary) and will earn academic credits for your Curtin University degree

or

- B. Is an approved leadership or community development program. This program will need to be approved by your JCUS co-ordinator as well as the Associate Director, Community Life.
- * Exemption: Health Sciences students are permitted to arrange programs such as placements and study tours which do not earn credits for their Curtin degree if they have a requirement to gain the necessary experience in order to enable them to work in their future professions. These programs might be arranged in Australia if an international experience in their discipline is not feasible, however Australian programs will only be considered in exceptional circumstances on a case by case basis for students who are required to work in remote areas in Australia. The decision on the feasibility of an Australian program rests with your JCUS coordinator.

Working in Australia with people from overseas, for example, would not be approved as an international experience.

You will be required to provide a report on your experiences, at the conclusion of your "international (or Australian) experience". This may take the format of a written report and/or a presentation.



HONOUR ROLL

As a JCUS Scholar, we would like to display your name, course and high school on the JCUS honour roll on the Curtin Scholarships website. The honour roll recognises our JCUS scholars and acknowledges their outstanding achievements.

CONDITIONS THAT NEED TO BE MET TO KEEP YOUR SCHOLARSHIP

- 1) Unless there are exceptional circumstances, you must:
 - Remain enrolled in initial course and major of study
 - Maintain a full-time enrolment of 100 credit points per semester at Curtin University. If any study is undertaken below 100 credit points in a semester, you are required to seek approval for this change from the Scholarships Office.
 - Remain eligible for a Commonwealth Supported place at the University (this means you must be an Australian citizen, holder of an Australian Permanent Humanitarian Visa, Permanent Resident or a New Zealand citizen).
 - Maintain a course weighted average (CWA) of at least 70 and pass all enrolled units. Academic monitoring will occur
 each semester.
 - Complete 2 hours of service per week over a period of 12 weeks each semester. This community service must be undertaken in a Curtin initiated project.
 - Attend all JCUS events.
 - Meet with your mentor as per required schedule set in JCUS handbook.
 - Complete a PPDP document, reflection and community service log each semester (refer to JCUS handbook)
 - Assist in the organisation of at least one JCUS event over the course of each year.
- 2) Deferral of this scholarship is not permitted
- 3) Behave in a manner consistent with the Student Charter and Student Conduct guide for students.
- 4) If you intend to take a leave of absence during your course, you must also apply in writing and seek approval from the Scholarships Office to suspend the scholarship for the period of the leave in addition to getting approval from your faculty. If approved, the maximum period of leave is 12 months.
- 5) Leave of absence may be permitted for up to a maximum of 12 months over the duration of the scholarship. You must apply in writing and seek approval from the Scholarships Office to suspend the scholarship for the period of the leave in addition to getting approval from your faculty.
- 6) If you cease studies at Curtin, either voluntarily (e.g. by withdrawing from course or units) or involuntarily (e.g. termination from course due to unsatisfactory course progress or suspension, termination or expulsion due to misconduct), you will become ineligible for continuation of this scholarship. The scholarship will cease immediately and you will be required to repay any stipend awarded for the most recent study period.

Unless there are **exceptional circumstances**, if you have unsatisfactory progress or breach the scholarship conditions, you shall be ineligible to retain the scholarship. If you do not meet all the conditions outlined, you may be placed on a breached status which would provide an opportunity for you to improve your grades in the subsequent semester. This opportunity would occur only once for the duration of the scholarship.

Exceptional circumstances must be forwarded in writing to the Scholarships Office, along with any supporting documentation. The Scholarships Office will then assess your request and advise you of the outcome.

PAYMENTS

The scholarship will commence from semester 1, 2015.

Payments for Option 1:

The fee component of the scholarship will be paid directly to your student fee account in two instalments per year to be paid prior to the census date relevant to each enrolled semester.

The semester cash payment of the scholarship will be paid to your nominated bank account. Payments will occur post census dates (thus approx mid-end April and mid-end Sept).

Cash payments are based on full-time enrolment of 100 credits per semester.

Payments for Option 2:

The semester payment of the scholarship will be paid to your nominated bank account. Payments will occur post census dates (thus approx mid-end April and mid-end Sept).

Cash payments are based on full-time enrolment of 100 credits per semester.

Payment for International Study Exchange:

The Scholarships Office will transfer the funds to your nominated bank account approximately 6 weeks prior to departure. This is dependent upon the Scholarships Office being advised of your intentions in time to allow the payment to be made in the appropriate timeframe. If you cancel your international experience after receiving the \$6,000 you will be expected to repay in full
