



MBA (GLOBAL) SCHOLARSHIP  
2015 TERMS AND CONDITIONS

**WHAT THIS SCHOLARSHIP PROVIDES**

The Master of Business Administration (Global) Scholarship for 2015 will provide the following support for the \*remaining expected duration of MBA (Global) program for up to a maximum of 2 years:

- 1) The 50% of the cost of the student contribution fees will be paid directly to the student fee account in two instalments per year to be paid prior to the census date relevant to each enrolled

\*The expected duration of the scholarship is based on recipients undertaking a full-time study load of 200 credits per year. Any study that is taken over and above the expected duration of your initial course will not be covered.

If you receive a Centrelink payment, you should declare to Centrelink any scholarships you are awarded.

The Australian Tax Office has a "[Is your scholarship taxable?](#)" tool on their website to help you determine if your scholarship is taxable. For expert advice please contact the Australian Taxation Office ([www.ato.gov.au](http://www.ato.gov.au)) or your accountant.

**CONDITIONS THAT NEED TO BE MET TO KEEP YOUR SCHOLARSHIP**

To retain eligibility for the MBA (Global) Scholarship you must:

- 1) Deferral of this scholarship is not permitted.
  - Remain enrolled in a MBA (Global) Program.
  - Maintain a full-time enrolment of 100 credits per semester at Curtin University. If any study is undertaken below 100 credits per semester, you are required to seek approval for this change from the Scholarships Office in consultation with a representative of the School of Management.
  - Maintain a course weighted average (CWA) of at least 70% and pass all enrolled units per semester. Academic monitoring of scholarship recipients will occur each semester.
  - Leave of absence is not permitted.
- 2) You are ineligible to apply for or receive any other Curtin funded scholarships whilst in receipt of the MBA (Global) Scholarship.
- 3) If you withdraw from your units or course of study or are terminated from your course of study, you will become ineligible for continuation of this scholarship. Your scholarship will cease immediately and you will be required to repay to Curtin University any fee contribution awarded for that study period.
- 4) The MBA (Global) Scholarship has been awarded for the MBA (Global) at Curtin University and is not transferable into any other course, major or university.

Unless there are **exceptional circumstances**, if you have unsatisfactory progress or who breach the scholarship conditions, you shall be ineligible to retain the scholarship. If you do not meet all the conditions outlined, you may be placed on breached status which would provide an opportunity for you to improve your grades in the next semester exams. This opportunity would occur only once for the duration of the scholarship and is at the discretion of the Scholarships Office in consultation with a representative of the School of Management.

**Exceptional circumstances** must be forwarded to and shall be at the discretion of the Scholarships Office in consultation with a representative of the School of Management. Supporting original documentation (e.g. medical, counselling) must be provided.

**PAYMENTS**

The MBA (Global) Scholarship will commence from Semester 2, 2015

The 50% of the cost of the student contribution fees will be paid directly to the student fee account in two instalments per year to be paid prior to the census date relevant to each enrolled semester.
