

## INDIGENOUS ACCESS SCHOLARSHIP (IAS) 2015 TERMS AND CONDITIONS

### WHAT THIS SCHOLARSHIP PROVIDES

The Indigenous Access Scholarship (IAS) for 2015 will provide the following:

- 1) \$4,823 one-off cash payment to assist with costs associated with studying (textbooks, incidental expenses etc.)

If you receive a Centrelink payment, you must declare to Centrelink any scholarships you are awarded.

### CONDITIONS THAT NEED TO BE MET TO KEEP YOUR SCHOLARSHIP

- 1) Deferral of this scholarship is not permitted.
- 2) Unless there are **exceptional circumstances**:
  - Remain eligible for a Commonwealth Supported place at Curtin University.
  - Remain enrolled as an Internal Curtin University student.
  - Maintain a full-time enrolment of at least 75 credit points per semester at Curtin University.
  - Be a commencing student at Curtin University in semester 1, 2015.
- 3) If you cease studies at Curtin, either voluntarily (e.g. by withdrawing from course or units) or involuntarily (e.g. termination from course due to unsatisfactory course progress or suspension, termination or expulsion due to misconduct) in the semester of award, you will become ineligible to receive this scholarship. The IAS will cease immediately and you will be required to repay any stipend awarded.
- 4) You must advise the Scholarships Office immediately if your financial situation improves from what was provided in your initial scholarship application.
- 5) The IAS is not transferable to another university.

### PAYMENTS

The scholarship will commence from semester 1, 2015.

The one-off cash payment of \$4,823 will be paid to your nominated bank account in mid-April 2015.\*

\*If you accept the IAS offer before census date, you will receive your payment in two equal instalments of \$2,411.50. The first payment will be made as soon as practical after you have accepted the IAS upon full-time enrolment. The second payment will be made in mid-April.

Cash payment is based on full-time enrolment of at least 75 credit points.
